## Objective

1. This form guide provides information on how to complete the fields in Form NP 727, or CBNI Declaration, how to submit a CBNI Declaration, and how to Retrieve/Void a CBNI Declaration.
2. This form guide is not the prescribed form under Section 60 of the Corruption, Drug Trafficking and Other Serious Crimes (Confiscation of Benefits) Act 1992.
