

LICENSING CONDITIONS FOR OPERATING AN AXE THROWING PE OUTLET

- 1 The licensee must take all appropriate steps to ensure that the following offences are not committed by any employee while on duty, or any patron or other person in the licensed premises:
 - (a) sale, consumption or trafficking of controlled drugs;
 - (b) use of criminal force;
 - (c) criminal restraint and confinement;
 - (d) intentional insult with intent to provoke breach of the peace;
 - (e) affray
 - (f) assault;
 - (g) rioting;
 - (h) sexual offences (e.g. rape or outraging of modesty);
 - (i) theft;
 - (j) robbery;
 - (l) gambling or betting;
 - (m) causing the disappearance of evidence after an offence has been committed.
- 1A The licensee shall ensure that the licensed premises does not promote, encourage or support, whether directly or indirectly, the offences set out in paragraph 1 above. This includes, but is not limited to, displaying or causing to be displayed, any message, picture, painting, poster, wall paper, or decoration which directly or indirectly depicts or glorifies the offences set out in paragraph 1.
- 1B Where any material promoting, encouraging or supporting, whether directly or indirectly, the offences set out in paragraph 1 above is found by the Licensing Officer, the licensee shall immediately take all necessary measures to remove, or cause to be removed, the material upon notification by the Licensing Officer and comply with any directions given by the Licensing Officer to this end.
- 2 If any of the offences set out in paragraph 1 has been committed in the licensed premises, the licensee –
 - (a) must report the offence to the police as soon as the offence comes to the licensee's knowledge;
 - (b) must not remove, conceal or obliterate any evidence of the commission of the offence;
 - (c) must not cause obstruction to the police officers investigating the offence; and
 - (d) must provide reasonable assistance to police officers when requested.
- 3
 - (a) The licensee must ensure that no person below 15 years of age is admitted into the licensed premises.
 - (b) A person who is 15 years of age or older but below 18 years of age is required to produce written parental consent before being allowed to play the axe throwing game in the licensed premises.
- 4 The licensee must put up signs in English at prominent locations in the licensed premises to warn patrons of the following restrictions:
 - (a) "No admission to persons below 15 years of age."
 - (b) "Persons who are 15 years of age or older but below 18 years of age is required to produce written parental consent before being allowed to play the axe throwing game in the licensed premises."
 - (c) "Gambling or betting is strictly prohibited in these premises."
- 5 The licensee must ensure that no student wearing his or her school uniform or any part of a school uniform, or a school T-shirt, is admitted into the licensed premises.
- 6 The licensee must not provide a change of clothes to any student.
- 7 The licensee must maintain a register showing particulars of its patrons (including spectators) in the following format:
 - (a) Name;

- (b) NRIC No. / FIN No., or Passport No. and Country of issue;
 - (c) Address;
 - (d) Date of birth; and
 - (e) Date and Time-In and Time-Out.
- 8 The licensee must inform the Licensing Officer of –
 - (a) any change in the composition of directors in the case of a company; or
 - (b) any change in partners in a partnership business within 7 days of the change(s) being effected.
 - 9 The licensee must notify the Licensing Officer of any change of layout and shall submit the Fire Safety and Shelter Department ("FSSD") Building Plan Reference Number within 7 working days, following the approval of the change by FSSD.
 - 10 Public entertainment must not be provided in the licensed premises beyond the hours stipulated in the licence or where the licensed hours have been varied, beyond such hours as may be prescribed by the Licensing Officer.
 - 11 The licensee must ensure –
 - (a) that the licensed premises is air-conditioned; and
 - (b) that all openings such as doors and windows are kept closed when the licensed premises is in operation.
 - 12 The licensee must ensure that all axe throwing games are supervised by referees who are familiar with rules of the game and must ensure that the rules and safety of players are not compromised.
 - 13 The licensee must ensure that before the commencement of the axe throwing game, the players are briefed on safety procedures, rules of the game, the game scenario and all other relevant safety matters.
 - 14 The licensee must ensure that all players have the required safety and approved equipment at all times when inside the arena.
 - 15 The licensee must ensure that spectators are not allowed into the arena while axe throwing activity is in progress.
 - 16 The licensee must ensure that the public entertainment is not likely to be offensive to any race, religion, ethnicity or nationality or potentially cause disharmony amongst different groups.
 - 17 The licensee must ensure that any axe or any other related axe throwing item or equipment in the arena which is defective must not be operated until proper repairs have been carried out.
 - 18 The licensee must keep a proper record of all notices, certificates of inspection, permits and other Relevant documents issued in connection with any axe, machine or equipment and to produce them to the enforcement officers for inspection when required.
 - 19 No Liquor is to be brought into the premises at all times.
 - 20 The licensee must not allow entry by any person who is drunk, intoxicated with liquor or reasonably known to have consumed liquor into the licensed premises at all times.
 - 21 All axes, if required to be moved within the premises, must be covered with a protective sleeve (covering sharp edge) and held by an employee of the premises only.
 - 22 All movement of axes in the premises must be done after operating hours unless there is an urgent requirement to replace the axe.
 - 23 The room where all the axes are kept must be locked and secured at all times.

- 24 All incidents of injury caused by axe must be reported to PLRD by the licensee within 24 hours.
- 25 The axe range must comply to all rules and regulations as stipulated by the National Axe Throwing Federation(NATF) at all times. Any breach detected or reported on the axe range by the NATF must be reported to PLRD as soon as possible by the licensee.
- 26 Certification by NATF must be submitted to PLRD within 1 month from the issuance of Public Entertainment Licence.
- 27 Any Changes of certification status by the NATF must be reported to PLRD within a week.
